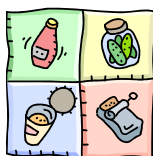

PLEASE SET RECYCLABLES OUT IN CLEARLY MARKED BINS OR IN PAPER GROCERY BAGS - BINS PREFERRED.



ACCEPTABLE PAPER ITEMS:

- Newspapers and inserts
- Magazines and catalogues
- Mixed paper and junk mail
- Shredded paper (in closed paper bags or clear plastic bags)
- Softcover books
- Phone books in bins or bags as separate item



ACCEPTABLE CONTAINERS:

NOTE: Remove all caps, lids and pumps; rinse. Labels do not need to be removed.

- Glass food and beverage containers
- Metal food and beverage containers
- Plastic bottles with a neck - juice, milk, soda, shampoo, etc.



CARDBOARD:

Needs to be tied in 3'x3'x16" bundles. Boxboard may be put with cardboard or in a separate bin or bag.

ACCEPTABLE BOXBOARD ITEMS:

- Cereal, cake, cracker, chip, cookie and pasta boxes
- Shoe, gift and electronic boxes
- Boxes from toothpaste, medications and other toiletries
- **NO** pizza, wax or coated cardboard is accepted.
