If you mail in your application, rabies vaccination records will be returned to you in the mail with your dog(s) license(s). **PLEASE NOTE:** Your application WILL NOT be considered complete unless it is accompanied by a current Rabies Certificate or proof of vaccination for each dog clearly identifying the date of rabies shot and rabies tag number. **OWNERS WITH MORE THAN 2 DOGS** must also obtain a Kennel Permit.
